In a scheme that was beneficial to both the stable and a handful of new owners exactly a year ago, Team Valor International for a second year in a row will offer certain equine interests in partnerships on an installment basis.

Last year, Team Valor marketed some of its interests in Sailor's Cap (left), a homebred juvenile colt that had broken his maiden nicely in New York. The son of Distant View went on to become a leader in the 3-year-old turf division this season, winning the \$600,000 Colonial Turf Cup. He makes his next start in the \$500,000 Grade 1 Hollywood Derby.

"We wanted to reduce some inventory, but we didn't want to take in too much more cash at the end of the year, so we offered interests in the colt on an installment basis, with three payments, spread out over November through next March. It worked out well for us, because we were able to achieve our goals and it worked out brilliantly for the newcomers, who wound up with a really nice horse."

Irwin also said "with good horses being so very difficult to locate, our being able to sell interests in current stock is a way to complete syndicates without having to rely on finding new product. We like what we own, we have had the animals for long enough to be able to evaluate them to a certain degree and we feel comfortable marketing them to prospective racing partners."

Newcomers, as they did with Sailor's Cap (who makes his next start in the \$500,000 Grade 1 Hollywood Derby), will be able to make three equal payments. Among the horses in which interests are available are the following:

- In This Life is the powerful filly from the first crop of Ghostzapper that also came from the sale
 at Saratoga. Ten percent is available. Syndication price is \$500,000. She was produced by a
 half-sister to the tremendous sire Indian Charlie, one of the few stallions in Kentucky to have
 his stud fee raised for season in a year when successful sires have had their fees reduced.
 She is training at Adena Springs South in Ocala, Florida.

- **Nylons** is a flashy filly by More Than Ready, the leading sire in earnings in the world in 2008. She figures to be a mature type to race well as a 2-year-old. Fifteen percent is available based on the original syndication price of \$275,000. She is at Eisaman Equine.
- **Golden Mexico** is set to arrive from Europe on November 17. This exceptional 2-year-old won his only start going long on the grass in Italy, a locale that has yielded Grade 1 winners and Champions Becrux and Sweet Stream for Team Valor. The first Team Valor horse to be sent to Christophe Clement, there is 10 percent available in him based on a value of \$440,000.
